Elected Sub-District Trustees

Elected sub-district trustees serve for a three (3) year term. Elected sub-district trustees may be re-elected for additional terms.

Trustee-At-Large

The Trustee-At-Large is appointed annually by the Ohio Lions Inc. State Council of Governors and serves for a one (1) year term. The Trustee-at-large is a voting member of the Board and may be re-appointed for additional terms.

Trustees Emeritus

Not more than five (5) former trustees who have served at least two (2) full terms as an elected trustee may be appointed by the Ohio Lions Foundation Board of Trustees as Trustees Emeritus to serve for a three (3) year term. Trustees Emeritus are voting members of the Board and may be reappointed for additional terms.

Honorary Trustees

Former members of the board of trustees who have served at least one (1) full term as an elected or appointed trustee and who in the opinion of the Board have rendered outstanding service to the OLF may be appointed by the Board of Trustees as an Honorary Trustee. Honorary Trustees are non-voting members of the Board.

Qualification of Trustees

Only members in good standing of a Lions Club associated with Multiple District 13 – Ohio Lions, Inc. shall be eligible to serve as a Sub-District Trustee, a Trustee-a-Large, a Trustee Emeritus, or an Honorary Trustee.

No person who has been convicted of a felony under the laws of the U.S. or of any state shall be eligible to serve as a Sub-District Trustee, a Trustee- at-Large, a Trustee Emeritus, or an Honorary Trustee. This limitation is applicable to elections and appointments of trustees after May 18, 2007.
